

EXPORT CONTROL COMPLIANCE VERIFICATION

The purpose of this form is to assist in verifying your export control status. U.S. laws and regulations prohibit the unauthorized export of restricted technology to certain persons. The Integrated Systems Sector, in order to comply with these legal requirements, must ascertain whether someone who may be given access to restricted technology is a "Foreign Person" subject to these export control restrictions. If someone is a "Foreign Person" for export control purposes, then he/she is subject to export control restrictions and may need to be granted an export license or other government authorization before being given access to restricted technology.

Certain categories of persons, referred to as "U.S. Persons" (including but *not limited to* U.S. citizens), are not considered "Foreign Persons"; they will therefore not need export licenses before being allowed access to restricted technology. The list of documents given in Section I below can be used to verify that someone is a "U.S. Person" (and not a "Foreign Person"). If a person whose export control status is being verified furnishes a document from the list in Section 1, then he/she is a "U.S. Person" (and not a "Foreign Person") for export control purposes, and will not need an export license before being given access to restricted technology.

Please review Section I and Section II below, and then fill out, sign and date **only the section that applies to you.**

You will be required to furnish original documents, except where noted, to verify the correctness of information you provide below.
